•§46 Pre-Sentence Investigation

A. Upon accepting a plea, verdict, or finding of guilt, the Court may direct that a pre-sentence investigation and report be completed. The report must be submitted to the Court and the Court shall then furnish a complete copy of the report to each party.

§48 **General Sentencing Provisions**

The sentencing policy of the Nation is to strive toward restitution, reconciliation, and rehabilitation. While one goal of sentencing is to impress upon the wrongdoer the wrong that has been committed, the paramount goal is to restore the victim and Nation to the position that existed prior to the commitment of the offense, and to restore the offender to harmony with them and the community by requiring them to right their wrongdoing.

In effectuating the Nation's sentencing policy, if the offender recognizes the wrong they have committed, and earnestly repents of such wrong, the Court in its discretion may:
